

Privacy Policy

Last updated: November, 2025

We take data privacy seriously. This Privacy Policy describes the privacy practices of Cong YU (“we”, “us”, or “our”)’s Power Remote:TV Remote(“App” or “Service”). We are here to support and protect your privacy decisions wherever you use our App or Service. If you do not want your data processed in accordance with this Policy in general or any part of it, you should not use our App or Service.

I. What data do we collect about you?

We collect data includes:

- IP address and the time zone.
- Email address.
- Device information includes device types and settings, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), browser types, mobile, wireless, operating system versions, another network information (such as internet service provider name, carrier name and signal strength), and application version numbers.
- Usage data includes the pages of our App you visit, the time and date of your visit, the time spent on those pages, and other diagnostic data.

II. How do we use the data we collect about you?

We use the information we collect about you for the following purposes:

- To provide you with our Service.
- To administer the App.
- To send you necessary communications.
- To conduct surveys and market research about our users.
- In connection with legal claims, compliance, regulatory and investigative purposes as necessary (including disclosure of information in connection with government agency requests, legal process or litigation).

III. Will we disclose your data to others?

We will disclose your personal data within our family of companies for the purposes

identified above. We will also authorize third-party service providers to use or disclose your personal data we make available to them to perform services on our behalf and to comply with relevant legal obligations. At last, we share your data when we believe it is necessary to comply with applicable law, to secure and protect the App and to enforce our contractual rights.

IV. What rights do you have?

Your rights in detail:

- Where we rely on consent you can withdraw your consent to the processing of your personal data by us at any time.
- You have the right to obtain access to your personal data that is being processed by us.
- You have the right to obtain from us without undue delay the rectification of inaccurate personal data concerning you.
- You have the right to obtain from us the erasure of personal data concerning you under certain conditions.

V. How long do we store your data?

We will store or retain your personal data for a commercially reasonable time and as long as needed or permitted, depending on the purpose for obtaining that data and consistent with applicable laws. We will anonymize or delete your data if the relationship between you and us has come to an end.

VI. How we secure your data?

We try our best to secure or protect your personal data. We employ administrative, technical, and physical security controls where appropriate, such as encryption, and appropriate contractual confidentiality obligations for employees and contractors.

VII. Can children use the App?

Children (individuals under the age of 13 or the equivalent age specified by law in your jurisdiction) are not allowed to use our App or Service. We also do not knowingly collect personal data from children.

VIII. Links outside

We are not responsible for the practices employed by websites or services linked to or from the App including the information or content contained therein. Please remember that when you use a link to go from the App to another website or apps, our Privacy Policy does not apply to third-party websites or services. Your browsing and interaction on any third-party website or service are subject to that third party's own rules and policies. This Privacy Policy does not apply to information we collect by other means (including offline) or from other sources other than through our App. You will need to make your own independent judgment regarding your interaction with any third-party website or service and carefully read their privacy policies and terms of services.
